INTRODUCTION

Papers from a southwest Missouri bank which was liquidated in 1929. Collection also contains material on the Lawrence County Land and Mining Company and the Stotts City Special Road District.

DONOR INFORMATION

The records were donated to the University of Missouri by Charles E. Ginn on 17 January 1945 (Accession No. 194).

SCOPE AND CONTENT NOTE

The collection includes only small portions of the bank's correspondence files dating from 1916 to 1928. Articles of association, bylaws, contracts, deeds, and income tax returns from the years 1898-1917 are included in the land and mining company files. The road district papers contain correspondence with investment firms, the state auditor, and bankers handling the bond accounts, 1915-1928. All are incomplete files.
